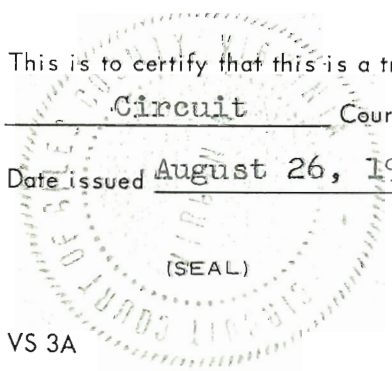

Thereupon the plaintiff produced Josephine Price and Victor Gonzalez, who, together with the plaintiff, gave evidence before the Court in support of the allegations of plaintiff's Complaint filed in this cause.

Thereupon this cause came on to be heard upon personal service of process duly had on the defendant in Harrison County, West Virginia, on the 28th day of June, 1963; upon plaintiff's Complaint, duly verified, and its exhibits, regularly filed in the Clerk's office of this Court on the 27th day of June, 1963; upon said notice that a trial of this cause would be demanded at this Term of Court; upon plaintiff's affidavit showing that the defendant is not in the Military Service of the United States of America; upon the testimony of the plaintiff and said witnesses adduced before the Court; and upon argument of counsel for the plaintiff.

Upon consideration of all which the Court is of opinion that the plaintiff is entitled to the relief prayed for in her said Complaint.

It is, therefore, adjudged, ordered and decreed that the plaintiff, Joyce Margaret Ferguson, and the defendant, Lee Franklin Ferguson, be and they are hereby divorced from each other and from the bonds of matrimony existing between them, and that the marriage heretofore entered into by the parties hereto on the 12th day of July, 1959, at Wayne County, West Virginia, and the same is hereby dissolved; it is further adjudged, ordered and decreed that the plaintiff shall not again marry within sixty (60) days from the date of the entry of this decree, and that the defendant shall not again marry within sixty (60) days from the date of the entry of this decree, except that the plaintiff and the defendant may be remarried to each other at any time.

And it appearing to the Court from the Complaint and the testimony adduced that there were born to said marriage two children, namely, Joy Lynn Ferguson, born August 11, 1960, and David Lelan Ferguson, born January 21, 1962, who have been in the care, custody and control of the plaintiff since the separation of plaintiff and defendant, and it further appearing to the Court that the plaintiff is a suitable person to have the care, custody and control of said children, it is, therefore, adjudged, ordered and decreed that until the further order of the Court, the care, custody and control of said children, Joy Lynn Ferguson and David Lelan Ferguson, be, and the same are hereby awarded to the plaintiff, with the defendant to have the right of reasonable visitation, under proper circumstances and upon proper conduct of the defendant.

It is further adjudged, ordered and decreed that the defendant pay unto the plaintiff for the support of said infant children the sum of Sixty Dollars (\$60.00) per month, until further order of the Court.

It is further adjudged, ordered and decreed that the defendant do pay the costs of this proceeding, including attorney fees to Ben E. Kyle, Jr., Counsel for plaintiff, in the sum of One Hundred Fifty Dollars (\$150.00).

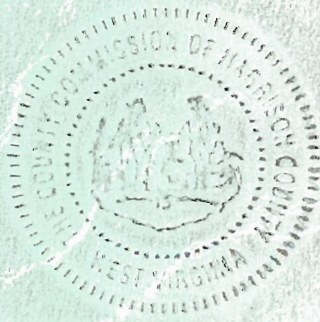
