Search Purpose: To identify, locate, prove and report the Decedent's Heirs at Law

Estate of: Joseph N. Sodaro

I. Research Conducted Within This Billing Period:

<u>Please refer to the attached genealogical chart (family tree)</u>, which we have compiled with the heirs we have identified to date.

We have reviewed the information regarding the Sodaro family provided at the commencement of our search and we have now confirmed that the Decedent had:

- Eight (8) Brothers and Sisters, all of whom are deceased
- Fifteen (15) Nieces and Nephews, seven (7) of whom are deceased and eight (8) of whom are living or believed to be living
- Seventeen (17) Grandnieces and Grandnephews, all of whom are living

To verify this information, we located Joseph N. Sodaro and his family in the 1910, 1920, 1930 and 1940 U.S. Federal Census enumerations, all of which identify his brothers and sisters as depicted on the family chart.

Giuseppe (Joseph) Sodaro and Rosa Bossie (Decedent's Parents):

 Located a reference to the Sodaro family in an online Rhodes Family Tree. This record reports that Joseph Sodaro was married prior to his marriage to Rosa Bossie; however, the name of the first wife was not listed.

- A search was conducted in Kanawha County, West Virginia for a marriage record for Giuseppe / Joseph Sodaro and a woman other than Rosa Bossie. No record was located.
- The 1910 census for Joseph and Rosa Sodaro, reports that they were married once to each other for nine (9) years.
- We searched to locate a birth record for any child born prior to 1901 (year of birth of their first child, Maria Sodaro), no record was located.
- Additional research located the name of the first wife identified in this Rhodes family tree
 as Barbie Bossie; however, according to Rosa Bossie's Certificate of Death (obtained
 during our research), her mother's name is Barbara Bossie. Therefore, it is our opinion
 that the individual providing the information for this family tree mistakenly identified
 Barbie as a wife of Joseph Sodaro.
- Obtained a copy of the Obituary for Rosa B. Sodaro, which identifies her survivors as her four daughters, Mrs. Frances Yeager, Mrs. Margaret Rhodes, Miss Anna Sodaro and Mrs. Van Gegumis and her five sons, George, Bernard, Joseph, Ernest and Phillip.
 - This record also reports that her husband, Joseph Sodaro died in 1925 and had been the owner of the Diamond Ice Cream Company.

Brothers, Sisters, Nieces and Nephews:

- Obtained copies of the obituaries for the following family members:
 - o Frances Morehead, Sister
 - o George Edward Sodaro, Brother
 - o Bernard Paul Sodaro, Brother
 - o Catherine Marie Gegumis Ellis, Niece
 - Robert Wesley Rhodes, Nephew
 - o Juanita Rhodes Chaffin, Niece

These records each confirm their survivors as their parents, siblings and or children as shown on the family chart.

- We have commenced contacting the Nieces, Nephews, Grandnieces and Grandnephews to confirm their current contact information and obtain the marriage records not yet received from your office.
- We spoke with Marie Annette Gegumis Insco (Daughter of John Van Gegumis) at the time of this reporting and she is sending us her marriage record, the marriage record for her sister, Catherine Allum and the birth records of her two (2) brothers, John and William Gegumis
